I am aware of and familiar with the inherent risks involved in the sport of skiing, trips, events, activities, lessons and any sport or social activities, and understand that I assume those risks for the minor child in my custody.

Ibex Ski Club reserves the right to withdraw a lesson, refuse to accept or retain a minor child in a lesson or to make changes to the published itinerary, whenever, in its sole judgement, conditions warrant or if it deems it necessary for the comfort, convenience, or safety of the child (ren).

If accepting of all the above conditions of Ibex Ski School, I will abide by the Constitution and By-Laws, Club policies, support its activities, pay the established dues. Child's Responsibilities

- 1. Minor child(ren) must be at least 8 years of age in order to participate in Ibex Ski School lessons.
- 2. The minor child will responsible for their own equipment which includes but is not limited to: locking up their own skis to deter theft and carrying their own equipment.
- 3. The minor child will show up at lesson time prepared to stay in class for the duration of the lesson, usually 1 to 2 hours. This means the child will be dressed appropriately for the weather conditions.

Parent's or Guardian's Responsibilities

- 1. Must accompany child to lesson, and remain on ski resort property until lesson is concluded.
- 2. Must provide child with appropriate equipment, whether that be the child's own equipment or rental equipment.
- 3. Ski equipment must be secured in time to attend the lesson at the stated time by the Ski School.
- 4. Must ensure that minor child has refreshments or money to purchase refreshments.
- 5. If minor child is deemed to misbehave based on the instructor's opinion, the child will be asked to leave the class and the parent or guardian will be asked to take responsibility for the child once the child leaves the class. The parent or guardian must receive approval from the Ski School Director before the child can be signed up for future instruction.
- 6. Parents or guardians are not allowed to be in the same class or monitor the class in which the minor child is taking instruction.

Note:

- 1. Members may be included in the same lesson with minor children due to skiing ability, number of instructors or class size.
- 2. Instructors receive no compensation for instructing on vacation trips, or scheduled instructions at local ski resorts.
